Part of our diverse offerings includes hosting a weekly community booth (free of charge) set aside for different interest and hobby groups/clubs to showcase their activities.

If you are a part of a club or organization that fits the following criteria, we encourage you to ask about being a part of our market:

Your club is non-religious and non-political in nature

Your club/organization has an activity, talent, display possibilities that are visual and interactive (e.g.: woodcarvers with woodcarving demos at the market)

Your club/organization would want a booth to hold a raffle from 10am–2pm

Your club/organization could hand out information about the group but not directly solicit membership at the market

You want to emphasize the demonstrative opportunities of the club – give people something to engage in as a way to tell your club's story

You would like to showcase items/art, but not directly sell these items at the market (there is a separate process for vendors, and a fee is applied for a weekly booth)

Musicians

Entertainers are asked to perform free of charge from 10am–2pm (with short breaks), arriving early for any set-up required. Feel free to put out a hat for tips, sell cd's and promote upcoming events.

We are booking one act per Saturday so groups will be placed on our calendar on a first come first booked basis. We are always looking for new and different music!

Must be signed or application will be returned. The undersigned agrees to exercise the utmost care in the use of facilities and properties of Silverton Health. The group also agrees to indemnify and save harmless Silverton Health, its officers, employees and agents from any and all claims, actions, judgments, losses, costs (including reasonable attorney fees) and damages whatsoever, including accident, injury, or death caused to persons or property of any kind, arising out of, in connection with, or incident to, the Marketplace, except caused by the sole negligence of Wellspring Marketplace. Should a group at any time occupy the premises in a manner contrary to the rules of the Marketplace, or in any manner that is hazardous or offensive to the public or vendors, upon request of Marketplace officials, group shall immediately cease such offending conduct. Failure to immediately conform as requested shall be cause to revoke this agreement. Upon failure to so vacate, the Marketplace is authorized to remove all property of group from the premises at group's expense. Wellspring Marketplace is relieved and discharged from any and all loss or damage occasioned by such removal. Wellspring Marketplace will not be responsible for storage or safekeeping of property so removed. This group understands that the premises are owned by Silverton Health and are used with the owner's permission. Permission to use the premises can be withdrawn at any time. The undersigned agrees not to hold the Wellspring Marketplace, its officers, directors, employees or agents responsible for any loss or damage claimed by the group should such permission to use be withdrawn.
